In exchange for being able to attend or obtain benefit from the Coastal Edge East Coast Surfing Championships presented by Vans produced by the Virginia Beach Jaycees (CE ECSC) and as a condition of receiving a media pass for the CE ECSC 2015 event (the "Event"), I agree: While I retain ownership and copyright in any audio-visual, visual, still image or moving content I create during the Event (the "Content"), I hereby warrant that I, and/or the media organization listed above, will not use any Content for any purpose other than editorial non-commercial use without CE ECSC and Virginia Beach Jaycees' express permission in writing. I agree not to provide any third party the rights to use or share the Content for any commercial or advertising use without the prior written permission of CE ECSC and Virginia Beach Jaycees. I will comply with all instructions from CE ECSC and Virginia Beach Jaycees staff, and will also comply with the CE ECSC and Virginia Beach Jaycees Rulebook in effect at the time of my attendance at the Event. I understand that I may not describe, or authorize the description of any CE ECSC and Virginia Beach Jaycees athlete as endorsing any product or service. I may not approach any CE ECSC and Virginia Beach Jaycees athlete for any reason without the athlete and CE ECSC and Virginia Beach Jaycees Event Media Manager's permission. Requests for athlete interviews must be directed to a member of the CE ECSC and Virginia Beach Jaycees Event media team. I will follow all applicable law and regulations in the Event location. In the event I create any Content at this Event or one in the future, CE ECSC and Virginia Beach Jaycees must approve any final cut of any commercial production using that Content prior to public display. A maximum of three (3) minutes of competition footage may be used in accordance with the terms of this accreditation per media outlet per day. I agree CE ECSC and Virginia Beach Jaycees has the right to approve or deny accreditation, and immediately revoke my credentials for the Event and remove me from the Event site if I fail to comply with these terms and conditions or the CE ECSC and Virginia Beach Jaycees Rulebook. Media passes must be worn at all times and are NOT transferable. RELEASE AND WAIVER: I acknowledge that the risks associated with attending or participating in the Event or activities surrounding the Event (which may include

my viewing the Event from a watercraft which is observing the competition in the open water) includes SIGNIFICANT RISK and I may suffer harm as a result of: (i) property or persons related to the event colliding or coming into contact with other persons or property, including myself; (ii) acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event; (iii) failure or unsuitability of facilities (including grand-stands, signage, fences and guardrails) to ensure the safety of persons or property at the Event; (iv) exposure to water (and possibly cold or polluted water) and the sun for a long period of time; (v) collision of the watercraft carrying me colliding with some other watercraft and/or mobile or immobile object (including if it gets caught by a breaking wave); (vi) I could lose my balance and fall from the watercraft; (vii) I could be exposed to rapid and adverse changes in weather, ocean and wave conditions; and/or (viii) I may be stung or bitten by an ocean creature, such as a bluebottle jellyfish, sea snake, stone fish, stingray or shark, and as a result I could suffer serious injury or death (including by drowning). I acknowledge that attending sporting events in general can be unpredictable, dangerous and accidents causing injury or death can and do happen and may happen to me. I acknowledge and warrant that if I attend the Event or another CE ECSC and Virginia Beach Jaycees event in the future or participate in any form in this the Event or a future CE ECSC and Virginia Beach Jaycees event, I assume all risks of physical illness, injury or death, any loss, damage or destruction of the my personal property and I do so at my own risk.
